Claims for non conformance of the Product(s) shall be barred at the end of the twenty four (24) months warranty period. Unibrain does not warrant that the Product(s) will operate in any specific combination which may be selected for use by Customer and/or that the operation of the Product(s) will be uninterrupted or error free and/or that all non-conformance or defects will be remedied. Additionally, Unibrain shall have no warranty obligations for any failure of the Product(s) to conform to the applicable Product(s) specifications resulting from the combination of any Product(s) with hardware and/or software not supplied by Unibrain.

The Customer shall pre-pay shipping charges for Product(s) returned to Unibrain and Unibrain shall pay freight charges for the return of the Product(s) to the Customer, excluding customs duties or taxes, if any. All returns require a dated proof of purchase by an authorized source of the Product(s) and the RMA form duly completed. Unibrain will not be responsible for Product(s) returned without an RMA or improperly packaged and/or damaged during carriage. If any Product(s) is reported as defective and/or non-conforming by Customer during the warranty period and said Product(s) shall be found not defective and/or conforming, Unibrain may, as its option, charge Customer for any labor provided and expenses incurred by Unibrain in connection with such determination, at Unibrain's then current rates.
